
2. As per documentary evidences submitted by the Secretary General of the Association during course of hearing on the objections of the complainant regarding eligibility criteria of the Chairman and Office bearers of the Association in Corporate Class are justified, hence objection of the complainant is dismissed.

3. Objection on the member of Executive Committee regarding change of class of membership from Corporate to Associate, it is clarified that if any member has changed his membership from Associate class to Corporate Class or Corporate Class to Associate Class being Executive Committee member, he shall lose his right to represent the class of membership of which he / she is no more a member. Renewal of membership for the concerned year is enough to declare the membership class of any of the members for said year. Therefore, the members of the Executive Committee who failed to meet the relevant class of membership during the renewal of membership for the proceeding year which they were appointed be de-seated.

4. The Secretary General of the Association is directed to submit compliance on the above directions and submit report to this office within 05 days of the receipt of this letter.
